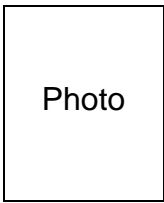

## PARENT/TUTOR AUTHORISATION AND GENERAL CONDITIONS Campus Chelsea FC

### GENERAL CONDITIONS:

1.- These general conditions are subject to existing laws and are binding for both parts, as are the special conditions agreed upon within the contract.

#### 2.- Registration, price and methods of payment.

Anyone interested in signing up for the Campus Chelsea FC should call the ESDE office and book a place in the student's name. They will then send in, by fax or email, the duly completed attached registration form as well as proof of payment of the required amount.

Detailed instructions regarding registration, price and payment methods can be found in appendix 1 to this contract.

Failure to complete the registration form (appendix 1), the medical form (appendix 2) or to make the required payment will result in the invalidation of the registration process.

#### 3.- Insurance.

Although the organisers of the campus have taken all necessary precautions to ensure optimal conditions of comfort and safety, football and other sports activities carried out during the Campus do entail a certain element of risk. Therefore, parents and guardians exempt ESDE and CHELSEA FC from any responsibility related to the practice of these Sports.

Although ESDE has taken out an insurance policy to cover all participants in the Campus in the event of any potential accidents, parents or legal guardians must pass on their own insurance details, in the event that an accident might occur.

#### 4.-Withdrawal from the course.

Should the parents, guardians or student decide not to participate in the Campus, this decision should be notified in writing to ESDE. If the cancellation takes place before May 27, the paid amounts will be refunded, except for the 500-Euro deposit. Past this date, no refunds will be carried out.

No refunds will be made should the student leave the Campus following a decision by the student, the parents or legal guardian.

Regardless of the moment in which the cancellation is made, the parents or legal guardians are responsible for covering all transportation costs, should their reimbursement not be possible.

#### 5.- Cancellation or changes in the activities.

ESDE undertakes to supply students with all the contracted services under the agreed conditions and characteristics.

ESDE will not be held responsible should the Campus be cancelled due to act of God or any abnormal situation beyond ESDE's control, of which the consequences could not have been prevented in spite of having acted with due diligence.

If for reasons beyond ESDE's control, or for weather-related reasons, one of the activities cannot take place, the organisers reserve the right to replace it with another activity of equal interest.

#### 6.- Rules of behaviour.

The student undertakes to comply with the rules of discipline of the Campus for the safety and wellbeing of all participants. In particular, they agree to comply with the rules relative to timetables, the obligation to attend classes, behaviour and life with other participants, teachers and monitors.

The possession and consumption of tobacco, alcohol, drugs and sharp objects are expressly prohibited, as are acts of vandalism, aggressions or damage caused to the premises or equipment. Failure to comply with these prohibitions or repeated non compliance with other rules will result in the immediate expulsion of the student, with no refund whatsoever. The student will also be responsible for any potential transportation costs and any inconvenience, with no prejudice of any other responsibility they might be subject to. Parents will be held responsible for any damage caused by students to the premises or installations used during the Campus, and will answer directly for any possible damage to the owners of the (RUT) Residencia Universitaria Teatinos, or Finca El Mazo.

In the event of expulsion, parents or legal guardians must collect their children within 24 hours following notification.

Parents or legal guardians give authorisation to the Campus director to inspect the student's room should the latter be suspected of being in possession of prohibited substances.

The Chelsea FC Campus reserves the right of admission.

Children will have access exclusively to the areas deemed appropriate by the organisers.



### 7.-Health conditions and urgent treatment.

Parents or legal guardians declare that the student is in perfect physical and mental health and that the information supplied in the "Medical Information" form (appendix 2) is accurate and complete. ESDE is exempt from any responsibility resulting from the false nature of the aforementioned information.

Also, ESDE should be informed of any medical or pharmacological treatment the student is to be subject to during his/her stay on the Campus. ESDE will make the decision to admit the student or not based on this information.

Should the student require any form of medical treatment during the Campus, including surgical, and the parents or legal guardians remain unreachable, ESDE is permitted to take the measures it deems appropriate for the student's health.

### 8.-Student image.

ESDE and CHELSEA FC reserve the right to use any photos or material supplied by students or their parents or legal guardians in the context of their participation in the Campus as advertising material, provided no prior opposition has been expressed. Nonetheless, this tacit authorisation may be revoked at any moment, which could result in compensation for ESDE or CHELSEA FC for any potential inconvenience this might entail.

### 9.- Protection of personal information.

In compliance with Law 15/1999 for the protection of information of a personal nature, ESDE guarantees full compliance with the rules of protection of information of a personal nature (Protección de Datos de Carácter Personal: LOPD).

Moreover, ESDE informs you that the personal data contained in these general conditions will be included in a file, which Mr. Andrew Bonich will be responsible for, for the operational and commercial goals of ESDE and CHELSEA FC. In accepting these general conditions, you agree that this information may be used as mentioned above, for the aforementioned goals.

ESDE's privacy policy guarantees the right to access, correction, cancellation and opposition, under the conditions stated in the existing laws, through written notification to ESDE Language Solutions, C/ Sierra de Grazalema 13, 29016 Málaga.

The Parent or Guardian agree that their personal information may be transferred, exclusively for the purposes stated in the second paragraph, to other entities dedicated to the purpose of this contract. Agreement from the parents or Guardians to the fact that their personal information may be processed or transferred as established in this paragraph is revocable, without this being retroactive, in compliance with articles 6 and 11 of Law 15/1999 of 13 December.
